## Terms and Conditions for the \$1500 Option: Collaboration with Erinem

## By purchasing this package, the buyer agrees to the following terms and conditions:

- 1. Upon purchasing this package, the buyer will receive a song by Erinem with an open verse. The buyer agrees to record their verse for the open section and send the isolated vocal recording (raw and unmixed) in .wav format to Erinem.
- 2. Erinem reserves the right to reject any verse if the content is objectionable or goes against Erinem's current branding.
- 3. The buyer understands that the song will be released one month from the time of receiving the vocal recording for the feature verse, plus an additional two weeks for pre-release to pitch the song to editorial playlists on Spotify.
- 4. Erinem reserves the right to reject any applicant for any reason. If this occurs, the buyer will receive a full refund immediately.
- 5. The artist purchasing the feature must write and record their verse in English.
- 6. The artist purchasing the package must already have a Spotify artist page.
- 7. The artist purchasing the package must have a Facebook and/or Instagram account if they wish to benefit from potential audience growth through the Meta Conversion Ads run for the song on these platforms.
- 8. The buyer understands that no growth (in terms of Spotify listeners, streams, followers, saves, or otherwise) can be guaranteed, although it is expected.
- 9. The buyer understands that no social media growth (on Facebook, Instagram, or other platforms) can be guaranteed, although it is expected.
- 10. The following is guaranteed for the buyer: a feature on an Erinem song, distribution to all major Digital Service Providers (DSPs), marketing through Meta Ads run by a professional in-house marketing team, professional mixing and mastering by an in-house engineer, and professional treatment of the buyer's vocals.
- 11. The song will reach Erinem's existing Facebook and Instagram audience, with a combined following count of 13.6k.
- 12. The song will reach Erinem's existing Spotify following of 2k followers, plus 3k monthly listeners.
- 13. The song will be pitched to Spotify Editorial Playlists; however, no inclusion can be guaranteed and is unlikely.
- 14. The song will be automatically included on the Release Radar playlist for Erinem's existing audience on Spotify, which occurs whenever a song is distributed as a pre-release on the platform.
- 15. Any further algorithmic playlist activity for the song is expected but cannot be guaranteed.
- 16. Upon purchase, the buyer will receive the song with Erinem's vocals within three weeks. The buyer then has up to 60 days to write and record their vocals for the open verse in the song. The buyer must submit a vocals-only file without effects and in English, accompanied by a document containing the lyrics for approval of content. Once approved, Erinem has an additional four weeks to release the song (two weeks for production and two weeks for pre-release).

- 17. If the content is found to be offensive or objectionable (e.g., hate speech, racist, or critically against Erinem's brand), the buyer will have a chance to revise their lyrics. If the buyer refuses revision or fails to satisfy requirements after two revisions, they will receive a partial refund of \$1200, with \$300 retained for Erinem's time.
- 18. If the buyer does not send a verse or fails to complete required revisions, no refund will be provided.
- 19. If the buyer submits improperly recorded vocals, they will have one opportunity to re-record the verse correctly. Failure to comply will result in a partial refund of \$1200, with \$300 retained for Erinem's time.
- 20. All prices listed are in USD according to the current value.
- 21. If instructions for recording, submitting, or participating in this process are ignored, Erinem reserves the right to cancel the feature and may or may not provide a refund, depending on the circumstances.

## The buyer must understand these risks before purchasing.

By purchasing this package, the buyer confirms their understanding of and agreement to these terms and conditions. Erinem shall not be liable for any indirect, incidental, consequential, or special damages arising out of or in connection with this agreement, including, but not limited to, damages for loss of profits, goodwill, or other intangible losses.

These terms and conditions shall be governed by and construed in accordance with the laws of the country in which Erinem is located. Any disputes arising out of or in connection with this agreement shall be subject to the exclusive jurisdiction of the courts of the country in which Erinem is located.

The failure of Erinem to exercise or enforce any right or provision of these terms and conditions shall not constitute a waiver of such right or provision. If any provision of these terms and conditions is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of these terms and conditions shall remain in full force and effect.

These terms and conditions, together with any other legal notices or agreements published by Erinem, shall constitute the entire agreement between the buyer and Erinem concerning the \$1500 collaboration package.
